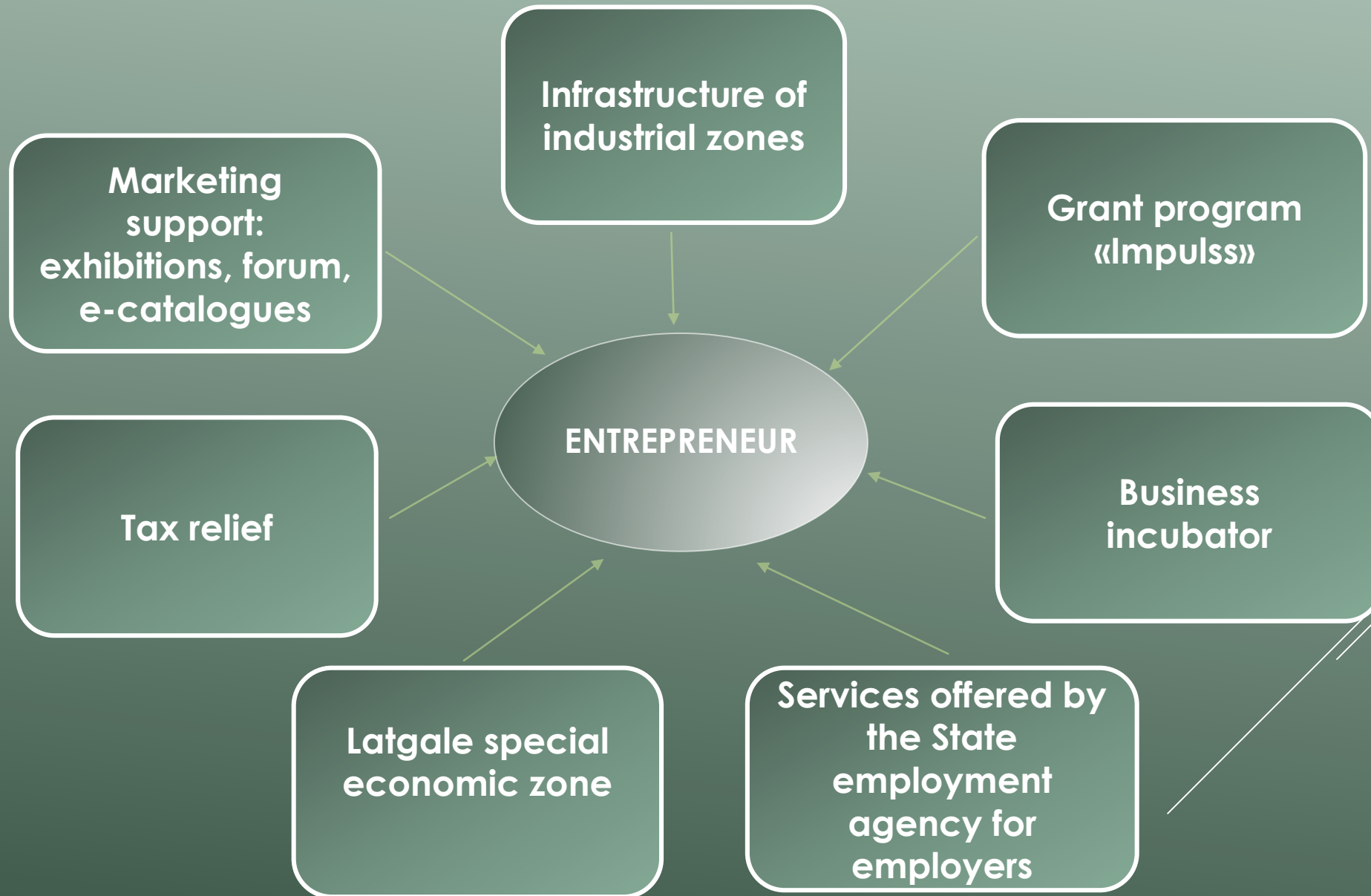

BUSINESS SUPPORT



Latgale special economic zone

80% relief for company income tax

up to 100% relief for property tax



Municipal grant program «Impulss»

Minimum Grant volume 5 000 EUR, maximum - 10 000 EUR

Up to 75% of total project implementation costs



Municipal co-financing:

co-financing up to 70% for connecting to a centralized water supply or sewerage system



Real estate tax relief:

Up to 25% of Real Estate Tax relief creating 5 jobs in current year

Up to 50% of Real Estate Tax Relief creating 50 jobs for people with disabilities (min 50 % of total employee number)

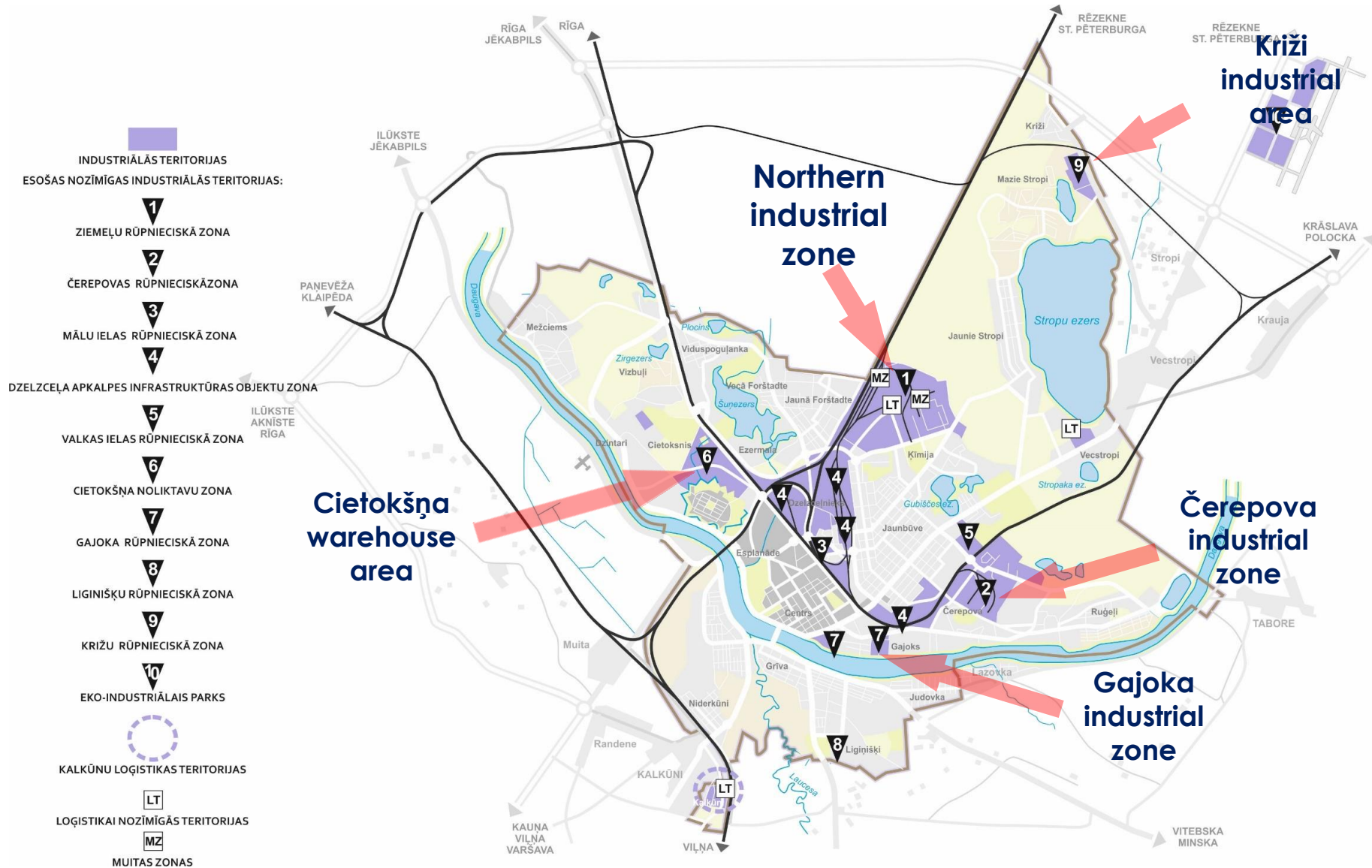


Revitalized industrial areas:

Reconstruction of Bruģu Street in the section from 18. Novembra Street to Ūdensvada Street and reconstruction of Dzirnāvu Street in the section from Vidus Street to Bruģa Street in the Gajoka industrial zone, Daugavpils.

KRIŽI INDUSTRIAL ZONE



Land improvement works (cleaning the territory from construction debris);
- construction of roads and building engineering systems (infrastructure).

SERVICES OFFERED BY THE STATE EMPLOYMENT AGENCY FOR EMPLOYERS

Registration of vacancies and selection of employees

- ▶ The employer can register the vacancy electronically on the SEA CV and vacancies portal or at the SEA branch office
- ▶ At the request of the employer, SEA staff organizes the selection of applicants from among the unemployed and job seekers, organizes a meeting between the employer and applicants in person or remotely using Zoom platform
- ▶ The European employment service network EURES publishes a vacancy open to jobseekers in the countries of the European Union (EU), the European Economic Area (EEA) and Switzerland and offers the assistance of a EURES consultant to recruit workers from other EU and EEA countries.

Support for the Employers Regarding Employment

- ▶ Wage subsidy support
- ▶ On the job training
- ▶ Subsidized workplaces (measures for certain groups of unemployed, including for the unemployed with disabilities)
- ▶ Employment of the unemployed with disabilities for an indefinite period
- ▶ Summer employment of students
- ▶ Support for regional mobility for the employer

REGIONAL MOBILITY SUPPORT FOR EMPLOYERS

If the employer ensures the employee's transportation from the place of residence to the place of work and back or the employee's accommodation

FROM THE SEA, YOU CAN RECEIVE:

- compensation for transport expenses up to 10 euros per day
- room rent and compensation up to 200 euros per month

The employment relationship must be established with an employee who was previously granted the status of unemployed

Unlike other special economic zones of Latvia, the location and area of each maximum territory that can be granted SEZ status has not been determined in the municipalities included in the Latgale planning region. In order for the process of determining the areas of territories to be flexible and to be able to adapt to the demand of the business environment, the territories to be included in the Latgale SEZ can actually be located anywhere in Latgale according to the discretion and needs of the company. Companies operating in the territories of the Latgale SEZ have the opportunity to apply for direct tax benefits.
